Criteria for a complete consultation

1. The honorarium of private empaneled doctors under DPMSU hub are disbursed after prescription audit and dashboard verification conducted by District team every month.
2. Those calls which are completed by private empaneled doctors after duty day (08:00am to 08:00 pm) cannot be considered for payment.
3. Private empaneled doctors under district hub should not be an employee of central government, State Government, National Health Mission or any other Government agencies

Roles and responsibilities of empaneled doctors:

1. Daily duty hours of specialist doctor are minimum 4 Hours with divided breaks of maximum 30 minutes.
2. Daily duty hours of medical officers are minimum 6 Hours with divided breaks of maximum 30 minutes.
3. If the private empaneled doctors under DPMSU hubs is physically working in the concerned district the basic arrangements for teleconsultation (PC/Laptop, High speed network, High quality camera and microphone) must done by district itself. If the doctor is working remotely, then the doctor must arrange the foresaid basic requirements themselves.
4. All private empaneled doctors should strictly use Laptop/PC for teleconsultation and must turn on Video and audio, for real time (Face to face) teleconsultation.
5. All private empaneled doctors are instructed to provide their duty schedule for next month (including time and date) to the District coordinators before 25th of every month. Any further changes will not be entertained.

General Terms & Conditions

1. Selection will be based on qualification, experience and performance in the Written test/ interview.
2. The selected candidates will be governed by the rules and regulations of NHM in force from time to time
3. Application should be submitted before 07.01.2025 5pm through the Google Form Links of concerned post given below.
